4. TRUSTEES

(i) The members mentioned here in above shall be individually known as Trustees and they shall occupy office for life.

(ii) Every Trustee is entitled to nominate any one of the person as his/her successor from among his/her family members to succeed him/her immediately by resigning his/her membership in the Trust. He / She can also nominate any one of the persons as his successor from among his/her family members to succeed him/her after his/her death. At the death of the Trustee, the person already nominated by him/her from his/her family will become the member of the Trust.

(iii) If however, the member Trustee does not make a nomination and the position of Trustee as occupied by such position becomes vacant for whatever reason, then the members of such persons family shall elect any one of the person from among themselves either unanimously or by simple majority for a specified period and shall communicate such nomination to the Trustee. The nomination referred to herein shall be given to all legal heirs of the deceased member of the family in writing and with the signatures of all the members of the family or as many members of the family as have been present while selecting the successor and present the same to the Trust within a period of 3 months from the date on which such a vacancy arises.

(iv) In the event of the Trustee not nominating a successor and in the event of the legal heirs of the family members not being able to select one from among themselves within the stipulated period of 3 months, then the entire family will forfeit their right to appoint a successor. In such an eventuality, it is open to the remaining Trustees holding office to resign by a simple majority to select any person from the legal heirs of the deceased member's family for a specified period.

- k) The Trust Board shall have the power to appoint an auditor and legal adviser for the Trust.

- p) Deciding opening of institutions, schools, colleges, Research Centre's and other ventures in consonance with the objectives of the Trust.
- q) The assets, fund and incomes of the Trust shall be solely utilized towards the objectives of the Trust and no portion of it will be utilized for the payment to the Trustees by way of profit, interest, dividend, etc.

f) lawfully to carry out transactions as they consider expedient in the interest of the Trust and to make all arrangements and do such acts and things on behalf of the Trust as may be usual necessary, desirable or expedient for the management of the affairs of the Trust or in carrying out its objects.

g) The funds of the Trust shall be invested by the board of Trustees for meeting out the objectives so depicted in the interests of the Trust. All the funds shall be invested in the modes prescribed under the provisions of section 13(1)(d) read with section 13(5) of the Income Tax Act as amended from time to time. The investments shall be in the name of the Trust.

h) The board of trustees has power to remove any trustees in case of any act against the objects of the Trust.

i) The trustees may contribute voluntarily any additional sum to the Trust and when the Trust is in need of additional funds for the development of the Trust or to carry out its object.

None of the Trustees shall have directly or indirectly any interest or concern in any transactions of the Trust. If in any transaction of the Trust any such Trustee has any interest or concern, such interested Trustee shall bring it to the Trust Board at a meeting and the interested Trustee shall not participate in the discussion on the subject nor shall he be entitled to vote on the subject. This restriction shall apply to the Trustee (which definition includes all Authors of the Trust).

Members shall have full right to inspect the Registers of Members, Minutes books of the Trust during the business hours of the Trust.

## 7. BOARD MEETINGS

- i) The Trust Board shall meet at least once in every three calendar months for the purpose of conducting the business of the Trust/resolving the affairs of the Trust. A minimum of four meetings must be conducted in a financial year.
- ii) The Secretary of the Trust in direction from the chairman shall ensure the meeting and deal with necessary matters for convening the meeting. The meeting notice should be sent by local delivery or by speed post / registered post.
- iii) The minimum of seven clear days notice shall be given for all such meeting except urgent meetings which can be convened by giving three clear days notice.
- iv) The Secretary shall also be bound to convene a board meeting if so requisitioned by a minimum of five members of the Board. The members of the board who so requisition the meeting shall give in subjects in writing which they want to be discussed at the requisitioned meeting or also fill details thereof. However, if such requisition is received duly signed by a minimum of five board members neither the secretary nor the chairman shall have any power to cancel the meeting.
- v) The quorum for a meeting shall not be less than of four Trustees or one third of the existing members of the Trust board for the time being.
- vi) No business at any meeting shall be transacted unless there is a proper quorum. If at any meeting the required quorum is not present within 15 minutes from the time appointed for the meeting, then the meeting shall stand adjourned to the same time, same day, same venue in the week following. If at such adjourned meeting also the required quorum is not present then the number of board members present at that meeting shall be the quorum.

201 The Board of Trustees at their meetings can pass resolutions on the subjects with respect to the Trust and in particular, they can frame rules and regulations and bye-laws for better management and administration of the Trust and also the institutions affiliated to the Trust.

203 The Minutes of the proceedings of the meeting of the Trust Board or any committees thereof shall be recorded either in a bound book or in computerized sheets which ensure unimpaired safe and secure storage. It shall be the responsibility of the secretary to ensure that the Minutes Book is maintained up to date and proper.

204 All the properties belonging to the Trust should be held in the name of the Trust. The documents related to the properties shall be represented by any two of its chairman, secretary and Treasurer for the time being. Similarly, if a decision is taken to dispose off any of the properties of the Trust, the documents connected therewith shall be executed jointly by any two of its chairman, secretary and the Treasurer for the time being. In all documents connected with the Trust, if any, to be made by the Trust, such documents shall be signed by any two of its chairman secretary and the Treasurer for the time being.

205 In all documents connected with the Trust such as building approvals water supply, applications with educational institutions and such other government and quasi government departments, if any, to be made by the Trust, such documents shall be signed by any two of its chairman, secretary and the Treasurer for the time being.

10) The Trust Board is empowered to sell the immovable properties which are found to be surplus or purchase new properties which are required for the fulfillment of the objects of the Trust. The Board should have the approvals from the Trustees and for such approvals, the resolutions shall be passed at a meeting of the Trustees and it requires 75% majority to pass the resolution.

11) At all the board meetings of the Trust, Chairman of the Trust Board shall be the Chairman, in the absence of the Chairman, the Vice-Chairman will preside the meeting. And in case both are absent one of the Trustees present shall elect one from among themselves to be the Chairman of the meeting.

**II GENERAL BODY MEETING:-**

1) The Secretary shall be bound to convene a general body meeting at once in every year to discuss the accounts and other matters. The notice period for the above meeting shall be minimum of 15 days days. The meeting notice should be sent by hand delivery or by speed post or registered post.

2) The Secretary shall also be bound to convene an extra-ordinary general meeting either based on the resolution passed in the board meeting or if so requisitioned by a minimum of seven members of the Trust. The members of the Trust who is requisition the meeting shall give in writing subjects in written which they want to be discussed at the requisitioned meeting as also full details thereof. However, if once a requisition is received duly signed by a minimum of seven members, Trustee along the subject that is proposed to be discussed as also the details thereof neither the secretary nor the Chairman shall have any power to cancel the meeting.

iii) The quorum for a meeting must not be the fewer of Twelve Trustees.

iv) No business at any meeting shall be transacted unless there is a proper quorum. If at any meeting the required quorum is not present within 15 minutes from the time appointed for the meeting, then the meeting shall stand adjourned to the same time, same day, same week in the week following. If at such adjourned meeting also the required quorum is not present then the number of Trustees present at that meeting shall be the quorum.

v) The Trustees shall also have the power to add, amend or delete any such rules provisions of the Trust from time to time according to the needs of the Trust at a meeting where Trustees are present and at least 3/4<sup>th</sup> members vote in favour of the resolutions.

vi) Unless specifically provided for herein, all resolutions in the meeting shall be passed by simple majority. For this purpose, each Trustee shall have one vote.

vii) The Minutes of the proceedings of the meeting of the Trust or any committees thereof shall be recorded either in a bound book or in computerized sheets which shall be maintained safe and secure in a binder. It shall be the responsibility of the Secretary to ensure that the Minutes Book is maintained up to date and proper.

#### 9. ASSETS OF THE TRUST

The Trust assets shall comprise of all funds received as donations whether in cash or kind or otherwise, all income from the investments, movable and immovable properties to be acquired by gift purchase, lease or otherwise and all the properties shall be held in the name of the Trust.

#### 10. ACCOUNTS OF THE TRUST

The accounts of the Trust shall be closed every financial year on 31st March and Income and expenditure account and balance sheet as on that date shall be prepared. The surplus fund if not applied within the financial year of accounts shall be accumulated for any specific object of the Trust and invested in any manner authorized under the Income Tax Act for the time being.

The accounts of the Trust shall be audited every financial year by a qualified chartered accountant or by a firm of chartered accountants.

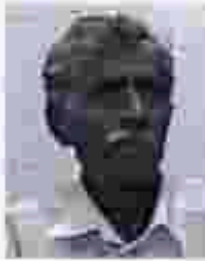
